

Harald and Dodie Ziemer Scholarship



Background

Harald and Dodie Ziemer immigrated to Australia from Germany in 1956. Harald was the Bursar of Luther College from 1981 until his retirement in 1995. Following Harald's death in 2013, his wife of 57 years, Dodie Ziemer, expressed a desire to establish a Scholarship Fund in his memory. In 2014, Dodie herself passed away leaving a legacy to fulfil her wish to establish the scholarship.

The Harald and Dodie Ziemer Scholarship has been established to express Harald and Dodie's gratitude to the members of the Lutheran Church in Australia, who accepted and supported Harald and Dodie over more than 50 years and provided a spiritual home away from their families in Germany.

Further contributions can be made by others under the name of the Scholarship to ensure the continuation of this perpetual Scholarship.

Eligibility

The Harald and Dodie Ziemer Scholarship will be awarded to a student of high academic potential whose family circumstance would otherwise not allow that child to attend Luther College. The Scholarship will be advertised when available and families will be required to apply for the scholarship and submit details about their student, including academic standing, and a confidential statement of their family financial circumstances.

The Harald and Dodie Ziemer Scholarship will be awarded at the discretion of the Principal and Scholarship Committee. The Scholarship will usually provide a tuition fee remission for a specified duration which will be advertised at the time of application.

Scholarship recipients are required to exhibit continued academic progress and support of the College ethos through the course of their enrolment at the College.

Criteria for Selection

Those students who receive scholarships will have exemplary character and will exhibit Christian values such as service, community, excellence and integrity.

7. A completed Family Financial Details Form.
